**Sub: - PIECEMEAL JOBS IN TBPPLANT IN PRODUCTION SECTION**

- 1 General Manager, Heavy Water Plant, Baroda for and on behalf of the President of India, invites sealed quotations from approved and eligible contractors for PIECEMEAL JOBS IN GENERAL SHIFT OF PRODUCTION SECTION.
  - 1.1 The estimated cost of the work is **Rs 9, 67,154** /- inclusive of **GST**.
  - 1.2 The tenders will be issued to eligible contractors provided they produce proof of having sufficient relevant experience along with list of available tools, tackles, manpower, and adequate facilities for the successful execution of the above mentioned jobs. **Contractor should abide by the governing rules of EPFO, ESIC & workmen compensation act.**
  - 1.3 Party must have executed similar works of PIECEMEAL JOBS IN ROUND THE CLOCK SHIFT AS WELL AS IN GENERAL SHIFT OF TBP PLANT IN PRODUCTION SECTION during the last 7 years. Only those bidders shall be issued tender who have executed a single job of 80% of the tender value, or two jobs of 60% of the tender value or three jobs of 40% of the tender value in a financial year. Relevant copies of work orders and certificates for jobs carried out are to be submitted along with request for issue of tender.

**Annual Turnover:** Bidder should have average annual financial turnover of at least **₹ 4, 83,577/-** during the immediate preceding 3 consecutive financial years. This should be duly audited by a registered Chartered Accountant and scanned copy of certificate from CA to be uploaded. Year in which no turnover is shown would also be considered for working out the average. They should not have incurred any loss (after deduction of tax) in more than two years during last 5 years period ending with 31.03.2019.
2. The works completed upto previous day of last date of submission of tenders shall also be considered.
3. Tender document for the above tenders can be obtained from Pay and Accounts Officer, Heavy Water Plant, P.O. Fertilizer Nagar, Dist. Baroda - 391750, on **payment of Rs. 500/--** (non refundable) on all working days from **13.05.2019 up to 23.05. 2019** during 10:30 Hrs to 15:00 Hrs.
4. The sealed quotations must be subscribed with reference number, **Due date** and **Name of the work** written on the envelope for the subject mentioned jobs and should reach Pay and Accounts Officer, HWP - Baroda by 14:30 hours on or before the due date for receipt i.e. **27.05.2019** which **shall be opened on the same day** at 15:00 hours in presence of the Tenderers / or otherwise. In case the date of receipt of opening is falling on public holiday, it shall be opened on the next working day at specified time. In case of postal request/ submission, HWP(B) will not be responsible for any postal delay

The Quotation must enclose Earnest Money Deposit of **Rs 19,343/-**. Offers received without EMD will be summarily rejected. All the DD's on account of EMD and SD & Performance Guarantee have to be drawn in favor of **Pay & Accounts Officer, Heavy Water Plant, BARODA, payable at Baroda.**

The latest Income Tax Certificate is also required to submit along with the quotation. Income Tax and Surcharge thereon shall be recovered from each bill as applicable at prescribed rates. You shall furnish PAN allotted by the Income Tax Authority.

It is mandatory for contractor to take insurance coverage for the entire period of contract.

Particular regarding registration and applicability of EPF Act, 1952 and ESIC shall be given by the contractor. EPF & ESIC will be reimbursable only on production of documentary proof.

**Tenderer should submit following data :**

- (A) Solvency certificate of 40% of tender cost from nationalized bank.
- (B) Income Tax PAN No
- (C) GST Registration number
- (D) EPF & ESIC registration
- (E) Annual Turnover Certificate for last three years
- (F) Profit & Loss Statement duly certified by C.A.

- 6 The Contractor should read the nature of job involved carefully. Contractor may visit the site and examine the working conditions and magnitude of job and he can hold discussions with HWP (B) Engineers for clarification before submitting the Tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.
- 7 The Competent Authority of Heavy Water Plant (Baroda) is not bound to accept the lowest or any tender and reserve to himself the right to accept the whole or any part of the tender and the tenderers shall be bound to perform the same at the quoted rates and as per terms and conditions of the contract either partly/on whole.
- 8 Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 9 Conditional and incomplete quotations in any form/ respect are liable to be rejected without inscribing any further reasons/ correspondence.

All tenders, in which any of the prescribed conditions are not fulfilled or found that the tender is not submitted in proper manner/ contains too many corrections/ absurd rates/ incomplete, are liable to be rejected.

- 10 No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of two years after his retirement from "Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractors services.
11. The quotation should be valid for acceptance for a minimum period of **90 days from the date of opening of tenders**. If the tenderer withdraws his tender with in the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall without prejudice to any other rights or remedy, be at liberty to forfeit 50% of said earnest money as aforesaid or remedy, shall take necessary decision for completion of work.
- 12 This Notice Inviting Tender in original, including additional conditions well as Memorandum of item rate Tender for work with signature on each page shall be submitted along with the offer/ quotation. These documents shall form a part of the contract document. The successful tenderer/ contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work sign the contract consisting of :
  - a. Fair Rates of Wages
  - b. Schedule of Qty. & Rates
  - c. AERB safety guide for works contract
  - d. General conditions of contract
  - e. Additional Terms and Conditions of the Tender.
  - f. Memorandum of Item Rate tender for the works and forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading there to.
