**NOTICE INVITING TENDER**

**TENDER NO.: - HWP/B/M/19-20/TS-733**

- 1 General Manager, Heavy Water Plant, Baroda for and on behalf of the President of India, invites sealed quotations from approved and eligible contractors for:  
“Fabrication, erection, installation and assembly of components of 24kA Sodium Cell at HWP, Baroda”
  - 1.1 The estimated cost of the work is ₹. 3,86,000/- inclusive of GST. The bidder shall quote as per schedule of quantities & rates inclusive of Goods and Service Tax (GST) as applicable.
  - 1.2 The tenders will be issued to eligible contractors provided they produce proof of having sufficient relevant experience along with list of available tools, tackles, skilled manpower, and adequate facilities for the successful execution of the above mentioned jobs.
  - 1.3 Party must have executed similar works of ‘**Metallic fabrication, Erection, installation**’ during the last 7 years. Only those bidders shall be issued tender who have executed a single job of 80% of the tender value, or two jobs of 60% of the tender value or three jobs of 40% of the tender value in a financial year. Relevant copies of work orders and certificates for jobs carried out are to be submitted along with request for issue of tender.
2. The above job should be completed in all respect to the satisfaction of the department within a period of **45 Days from** the date of the commencement of work. The date of commencement of work shall be intimated by ‘Letter of Commencement’ separately.
- 3 Tender document for the above tenders can be obtained from Pay and Accounts Officer, Heavy Water Plant, P.O. Fertilizernagar, Dist. Baroda - 391750, on **payment of ₹ 500/--** (non refundable) on all working days **from 23/09/2019, upto 03/10/2019** during 10:30 Hrs to 15:00 Hrs.
- 4 The sealed quotations must be subscribed with reference number, **Due date** and **Name of the work** written on the envelope for the subject mentioned jobs and should reach Pay and Accounts Officer, HWP - Baroda by 14:30 hours on or before the due date for receipt **i.e. 05/10/2019**, which **shall be opened on the same day** at 15:00 hours in presence of the Tenderers. In case the date of receipt of opening is falling on public holiday, it shall be opened on the next working day at specified time. In case of postal request/ submission, HWP (B) will not be responsible for any postal delay.
- 5 **EMD:**  
The Quotation must enclose Earnest Money Deposit of **₹ 7720/-**. Offers received without EMD will be summarily rejected.  
Earnest money given by all the Contractors (except the one who’s tender is accepted) shall be refunded after finalization of the tender on successful tenderer. EMD of successful bidder shall be returned after finalization of work order.  
All the DD/FDR on account of EMD and SD & Performance Guarantee have to be drawn in favor of **Pay & Accounts Officer, Heavy Water Plant BARODA, payable at Baroda.**

- 6 The latest Income Tax Certificate is also required to be submitted along with the quotation. Latest Income Tax clearance certificate shall be furnished along with the quotation. Income Tax and TDS on GST as applicable shall be deducted from RA bills & Final Bill at the prescribed rate.

**Tenderer should submit following data failing which tender shall not be considered.**

- (a) Solvency certificate of 40% of tender cost from scheduled bank.
- (b) Annual Turnover for the last 5 years. Average annual turnover for the last 3 financial years should be at least 50% of estimated value.
- (c) Profit & Loss Statement duly certified by C.A. Bidder should not have incurred any loss in more than two years during last 5 years of Profit Loss Statement ending 31st March 2019.
- (d) Goods and Services Tax Registration number.
- (e) Income Tax P.A.No.

7 **Performance Guarantee**

On receipt of the work order, contractor shall deposit a performance bank guarantee for an amount equivalent to 5% of the total amount quoted by the contractor by DD/FDR in favor of Pay & Accounts Officer, HWP (B).P.G. shall be released after successful completion of the work.

8 **Security deposit**

In the event of contract being awarded, Security Deposit will be deducted @2.5 % from RA bills & final bill. Security deposit will be refunded after completion of warrantee period from the date of issue of completion certificate for the work on satisfactory performance of service guarantee of 06 Month. In case of any defects noticed during the guarantee period, the contractor will be asked to rectify the defects within fifteen days, failing which the same will be rectified departmentally or otherwise at the risk and cost of the contractor.

9 **Warrantee/Guarantee:**

Work carried out should be guaranteed for a **period of 06 Months** from the date of completion of work against the defective workmanship and/or defective raw materials, and defects if found will be rectified immediately by the contractor on intimation.

- 10 The Contractor should read the tender documents and specifications carefully. Contractor may visit the site and examine the working conditions and magnitude of job and he can hold discussions with HWP (B) Engineers for clarification before submitting the Tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.

- 11 The Competent Authority of Heavy Water Plant (Baroda) is not bound to accept the lowest or any tender and reserve to himself the right to accept the whole or any part of the tender and the tenderers shall be bound to perform the same at the quoted rates and as per terms and conditions of the contract either partly/**or** whole.

Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.

- 12 Conditional and incomplete quotations in any form/ respect are liable to be rejected without inscribing any further reasons/ correspondence. All tenders, in which any of the prescribed conditions are not fulfilled or found that the tender is not submitted in proper manner/ contains too many corrections/ absurd rates/ incomplete, are liable to be rejected.

- 13 No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department Of the Government of India is allowed to work as a contractor for a period of two years after his retirement from "Government service, without the previous permission of the Government of India in writing, This contract is liable to be cancelled if either the contractor or any of his employees found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractors services.
- 14 The quotation should be valid for acceptance for a minimum period of **120 days from the date of opening of tenders**. If the tenderer withdraws his tender within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall without prejudice to any other rights or remedy, be at liberty to forfeit 50% of said earnest money as aforesaid or remedy, shall take necessary decision for completion of work.
- 15 This Notice Inviting Tender in original, including additional conditions well as Memorandum of item rate Tender for work with signature on each page shall be submitted along with the offer/ quotation.

These documents shall form a part of the contract document. The successful tenderer/ contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of :

- a. Applicable minimum Rates of Wages at HWP (B).
- b. Technical specifications & drawings
- c. Schedule of Qty & Rates.
- d. AERB safety guide for works contract.
- e. General conditions of contract.
- f. Additional Terms and Conditions of the Tender.
- g. Memorandum of Item Rate tender for the works.

forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

**The rate quoted shall remain firm throughout the currency of the contract. The contractor shall quote the rate taking into account of present minimum wages as applicable on the date of submission and any escalation of minimum wages during the contract period.**
