

1	Contractors who fulfill the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).	
A	Proof of registration with Government for testing laboratory & sub soil exploration in appropriate class.	
B	Should have satisfactorily completed the works as mentioned below during the last Seven years ending 31-01-2016.	
i)	Three similar works each costing not less than 40 % of the estimated cost or Two similar works each costing not less than 60 % of the estimated cost or One similar work costing not less than 80 % of the estimated cost.(work order & completion/performance certificate to be attached)	
	Similar works shall mean, "Geotechnical Investigation including at least one cross borehole test and analysis of the same"	
C	Average Annual Financial Turnover should be at least 30 % of estimated value during last 3 consecutive financial years. Bidder should not have incurred any loss in more than 2 years during the immediate last 5 consecutive financial years ending 31.03.2015. This should be duly certified by the Chartered Accountant	
D	Latest Bank solvency certificate from any scheduled banks of Minimum Value of 40 % of the estimated cost. (should not be older than one year from the date of opening of tender.)	
E	List of similar works in hand & similar works carried out by them for last 7 years indicating i) Agency for whom executed, ii) Value of work, iii) Completion time as stipulated and actual, or present position of the work.

2	The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT" CAREFULLY. He should only submit his bid if he considers himself Eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.	
3	Information and Instructions for tenderers posted on website shall form part of tender document.	
4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE and can be viewed in the website of www.hwb.gov.in Free of cost.	

5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft as EMD in favour of “ P&AO, HWP, Talcher payable at SBI, TFT Branch, Code No. 3312, Talcher, PO: Vikrampur, Dist: Angul (Odisha). ” (Demand Draft should have been drawn after the date of publication of NIT only) and other documents as specified.
6	Those contractors not registered on the website mentioned above, are required to get registered. If needed, they can be imparted training for online bidding process as per details available on the website.
7	The intending bidder must have valid class-III digital signature to submit the bid.
8	On opening date, the contractor can login and see the bid opening process.
9	Certificate of financial Turn Over: At the time of submission of bid, contractor may upload undertaking / Certificate from CA mentioned Financial Turnover of last 3 years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
10	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in YELLOW colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as “0” . Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as “0” (ZERO).
11	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted than the bid submitted earlier shall become invalid.
12	The department reserves the right to accept / reject any prospective application without assigning any reason thereof.
13	Income tax, Surcharge on IT, EC on IT & SC and Sales Tax shall be deducted from running bills and final bills as per the prevailing rates. The service tax shall be reimbursed on production of proof that the same has been paid by the party.
14	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by Heavy Water Plant, Talcher.
15	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in DCSEM.
PROSPECTIVE AGANCIES SHALL SATISFY THEMSELVES OF FULFILLING ALL THE NIT CRITERIA BEFORE SUBMISSION OF TENDER. Department reserves the right of non consideration of tender of the agencies not fulfilling the stipulated criteria.
