1	Contractors who fulfill the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).	
A	Proof of registration will Government / Semi Government organizations like DAE/BARC, CPWD, MES, BSNL, Railways etc. in appropriate class OR having experience in execution of similar nature of works.	
B	Should have satisfactorily completed the works as mentioned below during the last Seven years ending 31-03-2018.	
i)	Three similar works each cost not less than 40 % of the estimated cost or Two similar works each cost not less than 60 % of the estimated cost or One similar work costing not less than 80 % of the estimated cost.	
ii)	Similar works shall mean, " Miscellaneous works viz. Dissolution, Decontamination, handling, shifting etc of hazardous raw material in different facilities and Packing, weighment and storing of different finished products for their safe storage as well as dispatch, on as & when required basis to other DAE units"	
C	Annual turnover as per ITCC or profit & loss statement for the last 5 years (Average annual turn over for the last 3 financial years should be at least 30 % of estimated value put to tender, not having incurred any loss in more than 2 years during last 5 years ending 31.03.2017 (last financial year).	
D	Latest Bank solvency certificate from any scheduled banks of Minimum Value of 40 % of the estimated cost.	
E	List of similar works in hand & similar works carried out by them for last 7 years indicating i) Agency for whom executed, ii) Value of work, iii) Completion time as stipulated and actual, or present position of the work.	
F	List of Technical staff they possess.

2	The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT" CAREFULLY. He should only submit his bid if he considers himself Eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.	
3	Information and Instructions for tenderers posted on website shall form part of tender document.	
4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE and can be viewed in the website of www.hwb.gov.in Free of cost.	

5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards cost of Tender Documents fee and EMD in favour of "P&AO, HWP, Talcher payable at SBI, TFT Branch, Code No. 3312, Talcher, PO: Vikrampur, Dist: Angul (Odisha)." And other documents as specified.
6	Those contractors not registered on the website mentioned above, are required to get registered. If needed, they can be imparted training for online bidding process as per details available on the website.
7	The intending bidder must have valid class-III digital signature to submit the bid.
8	On opening date, the contractor can login and see the bid opening process.
9	Certificate of financial Turn Over: At the time of submission of bid, contractor may upload undertaking / Certificate from CA mentioned Financial Turnover of last 3 years or for the period as specified in the bid documents and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
10	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in YELLOW colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0" . Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
11	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted than the bid submitted earlier shall become invalid.
12	The department reserves the right to accept / reject any prospective application without assigning any reason thereof.
13	Income tax @ 2%, TDS @ 2% shall be deducted from running bills and final bills as per the prevailing rates. Rate quoted by the bidders should be inclusive of GST.
14	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by Heavy Water Plant, Talcher.
15	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in DCSEM.
16	It is mandatory that the successful bidder has to remit such contributions of EPF and ESI to the concerned authorities and shall submit the documentary evidence for reimbursement along with the bills for making payment. After submission of such documents only bill will be processed.
PROSPECTIVE AGANCIES SHALL SATISFY THEMSELVES OF FULFILLING ALL THE NIT CRITERIA BEFORE SUBMISSION OF TENDER. Department reserves the right of non consideration of tender of the agencies not fulfilling the stipulated criteria.
