Energy as the Government may decide in any of the posts mentioned in the schedule hereto to which he/she may be appointed. In the event of the trainee refusing or otherwise failing to accept service as aforesaid or in the event of the TRAINEE giving up or leaving the service before the expiry of the said period of three years after joining service, without the consent of the Government in writing or in the event of the TRAINEE being discharged or dismissed from service before the expiry of the said period of three years after his/her joining service on the ground of misconduct or negligence or dereliction of duty or violation of the service rules or on any similar ground, he/she shall refund to the GOVERNMENT without delay and in one lump sum a sum equal to the entire aggregate amount of stipend received by him/her during the period of his/her training together with interest thereon.

- 6) The category of post which may be offered to the TRAINEE are mentioned in the **Schedule A** and the choice as to which of the several posts is to be offered to the TRAINEE taking into consideration his/her qualification, experience and suitability will rest with the GOVERNMENT and not with the TRAINEE.
- 7) During the period of training, the TRAINEE shall not apply for any post or appear for any examination or interview without the prior permission in writing of the GOVERNMENT. If the TRAINEE has applied for any post or scholarship prior to his admission to the training course, he/she shall on admission withdraw all such applications and shall inform the authorities of the Heavy Water Plant (Manuguru) in writing of his/her having done so within ten days of his/her joining the training course.
- 8) The TRAINEE shall be entitled only to 8 days causal leave on medical certificate during the period of his/her training. He/she will not be entitled to any other leave and any leave availed of will be leave without stipend.
- 9) The TRAINEE shall observe and fulfill all the rules and regulations that may be framed from time to time for the maintenance of discipline and for promoting the efficiency of the trainees undergoing the said training course.
- 10) The GOVERNMENT notwithstanding anything herein contained shall be at liberty to discontinue the payment of stipend to the TRAINEE and to discharge the TRAINEE from training course at anytime without assigning any cause and without any notice and the TRAINEE shall not be entitled to claim any compensation from GOVERNMENT on that account.
- 11) The trainee shall devote his/her whole time to his/her duties as a TRAINEE and shall at all times observe the orders issued by and on behalf of the GOVERNMENT from time to time in relation to the training course and shall not, except in the case of an accident or sickness certified in writing by such Competent Medical Authorities as the GOVERNMENT may prescribe, absent himself from attending the training course without first obtained the permission in writing from the officer(s) nominated in his behalf.
- 12) The TRAINEE shall employ himself/herself honestly, efficiently and diligently to his/her work and study during the period of his/her training.
- 13) The trainee shall not publish the result of his investigation made while under training without the prior approval in writing of the GOVERNMENT.

- 14) All investigators made all methods or improvement discovered by the TRAINEE during the period of his/her training shall be for the benefit of the GOVERNMENT and these shall absolutely belong to the GOVERNMENT.
- 15) The TRAINEE hereby undertakes and agrees that in the event of the TRAINEE committing breach of any single or more of the terms and conditions contained in this agreement and on the part of the TRAINEE to be fulfilled, observed and performed the TRAINEE shall be liable to pay to the GOVERNMENT forthwith the entire amount of stipend received by the TRAINEE from the GOVERNMENT under this agreement or otherwise in the course of his training in the training course and the TRAINEE binds himself to the GOVERNMENT to pay it without delay and in one lump sum together with interest thereon.
- 16) All moneys that may be found to be due under this Agreement from the trainee shall be recoverable from him/her as arrears of land revenue under Revenue Recovery Act, 1890.
- 17) The decision of the being, as to whether or not the TRAINEE has observed and fulfilled all the rules and regulations framed and issued from time to time in relation to the training course or as to whether or not the TRAINEE has complied with the provision contained in clauses 11, 12, 13 and 14 of this agreement shall be binding on the trainee and such decision shall never be disputed by him/her.
- 18) It is agreed by and between the parties hereto that if during the continuance of this agreement or at any time thereafter, any question, dispute or difference shall arise between the parties or their respective heirs, legal representatives and administrators with regard to the construction of any of the terms, provisions or conditions herein contained or any act, deed or thing, done or to be done in pursuance hereof or any other matter or thing, relating to touching or arising out of this agreement or with regard to the quantum of any amount payable by the TRAINEE to the GOVERNMENT pursuant to the obligations and liabilities of this agreement all such questions, disputes or differences (except the decision whereof is expressly otherwise provided for in this Agreement) shall be referred to the sole arbitration of the officer appointed for this purpose by the General Manager, Heavy Water Plant (Manuguru) for the time being and the decision of such arbitrator shall be final and binding on the parties of the agreement. The Provisions of the Indian Arbitration Act, 1940 or any statutory modification or re-enactment thereof and the rules made thereunder for the time being in force shall apply and this agreement shall be deemed to be a submission to arbitration with in the meaning of the said Act. And it is also agreed that there will be no objection to the appointment of the arbitrator as above that the arbitrator is a Government Servant and as a Government servant in the course of his duty has expressed any views on the question of the points in dispute at anytime (while dealing with matter to which this agreement relates). The arbitrator shall always have the right from time to time to extend the time for making the award with the consent of both the parties.
- 19) It is agreed that the stamp duty on this document, if any, shall be borne by the Government.
